### MEMBERSHIP HOLD PROVISION *(Please read and sign)*

As an accommodation to our members, the YMCA has made provisions for memberships to be placed on hold. Please note and initial the following:

- Holds take effect at the beginning of the next draft cycle with 14 days notice
- Membership dues automatically return to original draft amount beginning the month you’ve indicated below. The start date is determined by your original draft date.
- For annual invoice members, the membership will be extended the same amount as the hold length of time. Annual invoice members must pay the \$10 monthly fee for each month they were on leave when they return. If you cancel your membership, your \$10 monthly fees will be deducted from any refunds due to you. (The fee is \$5 for Local YMCA facilities.)
- At the time of request, we will collect all membership cards until the membership is reinstated.
- If you have a locker and wish to keep it until you return, you will be required to pay the monthly locker dues during your leave. If you choose to terminate your locker, you must remove your belongings prior to your hold period. You may select another locker upon your return.
