

YMCA of Greater Seattle 150th Anniversary Giveaway

Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Sponsor

The YMCA of Greater Seattle 150th Anniversary Giveaway ("Giveaway") is sponsored by YMCA of Greater Seattle, located at 909 4th Ave Seattle, WA ("Sponsor").

2. Eligibility

The Giveaway is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry. The Giveaway is void where prohibited or restricted by law.

3. Giveaway Period

The Giveaway ends on August 7, 2026, at 12:00 p.m. Pacific Time ("Giveaway Period"). Entries received after the Giveaway Period will not be eligible.

4. How to Enter

To enter during the Giveaway Period:

1. Like the official Giveaway post.
2. Follow @SeattleYMCA on the platform where the Giveaway post appears.
3. Tag a friend in the comments on the official Giveaway post.

Limit one entry per person, regardless of the number of comments submitted. Entrants must have a public or otherwise verifiable social media account so the Sponsor can confirm eligibility and entry requirements.

No purchase, payment, donation, or YMCA membership is required to enter or win.

Incomplete, automated, fraudulent, or otherwise noncompliant entries may be disqualified at the Sponsor's discretion.

5. Prizes

Three prizes will be awarded, with one winner selected for each prize:

Prize 1: 15-Month YMCA of Greater Seattle Family Membership and \$150 Program Credit

One 15-month family YMCA of Greater Seattle membership, plus a \$150 credit toward eligible YMCA of Greater Seattle programs or services, such as personal training, swim lessons, or Pilates.

The approximate retail value of the prize is \$2,539.

The membership and program credit are subject to YMCA of Greater Seattle policies, eligibility requirements, location and program availability, registration requirements, and standard terms. The \$150 credit may only be applied to eligible YMCA of Greater Seattle branch programs or services and may not be redeemed for cash (does not include Day Camp or Overnight Camp). Any costs exceeding the \$150 credit are the winner's responsibility.

Prize 2: Family Camp Weekend for Four

One Family Camp weekend for up to four people at YMCA Camp Colman or YMCA Camp Orkila, with an approximate retail value of \$900.

The Family Camp prize includes lodging, meals and optional, scheduled activities. Transportation and other incidental expenses are not included. Dates and location are subject to availability and any applicable program requirements.

The prize must be redeemed by the end of 2027.

Prize 3: YMCA Online Store Credit

One \$150 credit to the YMCA of Greater Seattle online store.

The store credit is subject to applicable online store terms and may not be used toward shipping, taxes, or excluded merchandise unless otherwise stated. The credit must be redeemed by the end of 2027.

The total approximate retail value of all prizes is \$3,589.

Prizes have no cash value and may not be transferred, exchanged, or redeemed for cash. The Sponsor may substitute a prize of equal or greater value if an advertised prize becomes unavailable.

Each entrant is eligible to win no more than one prize.

6. Winner Selection and Odds

One potential winner will be selected for each prize through a random drawing from all eligible entries received during the Giveaway Period.

The drawings will take place on or around August 7, 2026, at 1:50 p.m. Pacific Time as part of YMCA of Greater Seattle's 150th anniversary celebration.

Odds of winning depend on the number of eligible entries received.

7. Winner Notification

Potential winners will be contacted through a direct message from the official @SeattleYMCA account.

The YMCA of Greater Seattle will never require a winner to pay a fee or provide payment information to claim a prize.

Potential winners must respond within [48 HOURS/THREE BUSINESS DAYS] of the initial notification. A potential winner may be required to provide proof of age, residency, identity, and eligibility and to complete an eligibility affidavit, liability release, or other prize-related documentation.

If a potential winner:

- Cannot be contacted;
- Does not respond within the required period;
- Does not meet the eligibility requirements;
- Does not complete required documentation; or
- Declines the prize,

the potential winner may be disqualified, and an alternate winner may be selected through another random drawing.

8. Taxes and Expenses

Winners are responsible for all federal, state, and local taxes and any costs or expenses associated with accepting or using a prize that are not expressly included in these Official Rules.

9. General Conditions

By entering, each entrant agrees to:

- Follow these Official Rules;
- Accept the Sponsor's decisions as final and binding;
- Release and hold harmless YMCA of Greater Seattle and its employees, officers, board members, representatives, partners, and agents from claims arising from participation in the Giveaway or the acceptance or use of a prize, to the extent permitted by law; and
- Allow the Sponsor to verify the entrant's eligibility and compliance with these Official Rules.

The Sponsor reserves the right to disqualify any entrant who tampers with the entry process, violates these Official Rules, acts fraudulently, or interferes with the fair administration of the Giveaway.

The Sponsor may cancel, suspend, modify, or terminate the Giveaway if fraud, technical failures, unauthorized intervention, or circumstances beyond the Sponsor's control affect the integrity or administration of the Giveaway.

10. Publicity

Except where prohibited by law, acceptance of a prize constitutes permission for YMCA of Greater Seattle to use the winner's first name, last initial, city and state, likeness, and prize information for promotional purposes without additional compensation.

11. Privacy

Personal information collected in connection with the Giveaway will be used to administer the Giveaway, verify eligibility, contact potential winners, and award

prizes. Information will be handled in accordance with YMCA of Greater Seattle's applicable privacy policies.

12. Social Media Disclaimer

This Giveaway is not sponsored, endorsed, administered by, or associated with Instagram, Facebook, Meta, or any other social media platform on which it is promoted.

By entering, participants release Instagram, Facebook, Meta, and the applicable social media platform from any responsibility or liability associated with the Giveaway.

Entrants understand that they are providing their information to YMCA of Greater Seattle and not to Instagram, Facebook, or Meta.

13. Governing Law

The Giveaway and these Official Rules are governed by the laws of the State of Washington, without regard to conflict-of-law principles.
